# REGULAR BASIC COURSE

## Modular Format Academy- Module III

### COURSE DESCRIPTION:

This course satisfies training requirements of the Commission on Peace Officer Standards and Training (POST) Module III. Topics include: property crimes, crimes against persons, crimes against the justice system, laws of arrest, search and seizure, presentation of evidence, patrol techniques, vehicle pullovers, crimes in progress, lifetime fitness, and career preparation. POST certification #2970-00133. Pass/No Pass only.

*Students are required to participate in practical hands-on and physically demanding training exercises that include risk of injury.*

### ENROLLMENT LIMITATIONS:

Students must 1) be free of felony convictions 2) possess a valid California Driver's License 3) undergo a fingerprint and criminal history check 4) be a minimum of 18 years of age 5) be a United States high school graduate, pass the GED, pass the California High School Proficiency Examination, or have attained a two-year or four-year degree from an accredited college or university, and 6) complete a medical suitability examination.

Module III consists of 192 instructional hours and meets on a weekly basis:
