## **BACKGROUND INVESTIGATIONS**

COURSE DESCRIPTION:

This course is designed for law enforcement or civilian personnel who are responsible for conducting background investigations for the hiring of public safety personnel. Topics include the background process, psychological evaluations, interviewing techniques and documentation. This course is approved by the California Commission on Peace Officer Standards and Training (POST). Pass/No Pass only.

Upon completion of the course, all students will receive an ARC SRPSTC Certificate of Completion and a grade submitted for their college transcripts.

ENROLLMENT: \*Mandatory College Enrollment Instructions / to obtain your college Student ID# (SID#):
