COURSE DESCRIPTION:

IMPORTANT:

ON: This course updates field training officers on new training methods, new policing methods, and legal liabilities. Topics include academy update, remediation methodologies, tactical communications, adult learning theories, ethics, liability, and supervision. Pass/No Pass only.

Upon completion of the course, all students will receive an ARC SRPSTC Certificate of Completion and a grade submitted for their college transcripts. Only in-service peace officers shall receive POST credit.

<u>Important Note:</u> Students are strongly encouraged to arrive on time in order to complete the registration process and avoid impeding instructional time. Late students who miss this process will not be allowed to attend the course.

ENROLLMENT:
