INTERVIEW AND INTERROGATION TECHNIQUES

COURSE DESCRIPTION:

Interview and Interrogation Techniques is a 40-hour course designed to teach law enforcement officers the legal and behavioral techniques of interview and interrogation. Topics include: court preparation, polygraphs, predictable behavior and the Ten Step Plan.

Upon completion of the course, all students will receive an ARC SRPSTC Certificate of Completion and 2 units through American River College. Only in-service peace officers shall receive POST credit.

Important Note: *Students are strongly encouraged to arrive on time in order to complete the registration process and avoid impeding instructional time. Late students who miss this process will not be allowed to attend the course.*

PREREQUISITES:

POST certified basic law enforcement academy or equivalent as determined by the Dean of Academy Instruction. **NOTE:** Approval of equivalent training is not a guarantee state regulatory or licensing agencies will also grant equivalency.

INTERVIEW AND INTERROGATION TECHNIQUES

ENROLLMENT: *Mandatory College Enrollment Instructions / to obtain your college Student ID# (SID#):
