PERISHABLE SKILLS & LEGISLATIVE MANDATES

COURSE DESCRIPTION:

This course is designed to meet the 2-year perishable skills training cycle requirements for [active] California peace officers. Course content consists of instructional blocks which update and advance the student's existing knowledge and skill set associated with providing public safety in fluid and dynamic multicultural communities. Instruction includes strategic communication, first aid/CPR/AED update, tactical firearms, arrest and control, and may include additional topics determined by legislative mandates and/or regional needs. Formerly SCSD 1150. Pass/No Pass only.

This course is designed to provide practical hands-on training in police tactics and weapon usage. Participants in this course will engage in physically demanding classroom training exercises that include a risk of injury.

Students must complete all 24-hours of the course (all blocks of instruction) in order to pass the course. Upon completion of the course, students will receive an ARC SRPSTC Certificate of Completion.

IMPORTANT NOTES:

- Students are strongly encouraged to arrive on time in order to complete the registration process and avoid impeding instructional time. Late students who miss this process will not be allowed to attend the course.
- 2. Students are expected to bring their agency's duty firearm, ammunition, and equipment. Please see below (page 3) for the comprehensive list of required items.
- 3. Personal firearms are not allowed. Students who bring unapproved/unauthorized firearms or ammunition will be dismissed from the class.
- 4. All students are REQUIRED to be current peace officers.

PREREQUISITES:

California POST-certified basic law enforcement academy within two (2) years or equivalent as determined by the Dean of Academy Instruction (Chapter 11, California Code of Regulations, Section 1005). NOTE: Approval of equivalent training is not a guarantee state regulatory or licensing agencies will also grant equivalency.

ENROLLMENT LIMITATION:

Students must 1) be free of felony convictions; 2) possess a valid California Driver's License; 3) undergo a fingerprint and criminal history check [if not an active peace officer]; 4) be a minimum of 18 years of age; 5) be a United States high school graduate; pass the GED, pass the California High School Proficiency Examination, or have attained a two-year or four-year degree from an accredited college or university; and 6) complete a medical suitability examination.
