# TRAFFIC COLLISION INVESTIGATION (INTERMEDIATE)

COURSE DESCRIPTION:

Traffic Collision Investigation (Intermediate) is a 40-hour course designed to expand the investigative knowledge and skills of the traffic collision investigator. Topics include definitions and terminologies associated with minor and major collisions, measuring and diagramming the collision scene and speed computation.

Upon completion of the course, all students will receive an ARC SRPSTC Certificate of Completion and a grade submitted for their college transcripts. Only in-service peace officers shall receive POST credit.

The course will use extensive practical application and field exercise, which <u>will require</u> additional course work outside of class hours.

<u>Important Note:</u> Students are strongly encouraged to arrive on time in order to complete the registration process and avoid impeding instructional time. Late students who miss this process will not be allowed to attend the course.

PREREQUISITES:

Successful completion of Traffic Collision Investigation (Basic). Prerequisites will be checked

prior to the first day of training.

MATERIALS NEEDED: Current vehicle code and a highlight marker pen. Clothing appropriate for weather.

Suggested items: Digital or Polaroid camera and drawing materials.

#### **ENROLLMENT:**
