As of June 30, 2021, The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs was 80,928.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

Per guidance from the US Department of Education, Los Rios utilized Free Application for Federal Student Aid (FAFSA) and the California Dream Act Application (CADAA) data on "Unmet Need" (the estimated cost of attendance minus a student's reported access to financial resource, per their FAFSA and CADAA) to determine student eligibility. These grants ranged between \$100 and \$600, based on the student's financial need and the number of units the student was enrolled in the applicable semester.

Additionally, to be eligible for the CARES Emergency Fund program, students must have meet the following requirements:

- a. Have a temporary need resulting from a sudden, unexpected emergency event
- b. Have been impacted by COVID-19
- c. Be currently enrolled in at least six units at a Los Rios college
- d. Have been enrolled in at least six units during the spring 2020 semester at a Los Rios college
- e. Be making Satisfactory Academic Progress and have a 2.0 or higher grade point average (GPA) or higher

A maximum of one \$500 CARES Emergency Fund award was given to any one student during all combined enrollments at the Los Rios colleges.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Emergency financial aid grant information is included in the Remote Campus Information for Students, and Higher Education Emergency Relief Fund (HEERF) Grant and Emergency Grants for Students.
